Entry Restrictions	<p>This promotion is only open to residents of [Australia – ACT, NSW, QLD, VIC, SA, NT, WA, TAS]. Entrants under 18 years of age must get permission from a parent or guardian before entering. Employees (and their Immediate Families) of the Promoter, or any of their respective parent companies, subsidiaries or affiliated companies, or any agencies associated with this promotion are ineligible to enter.
